What's a *cookie*?

Cookies are files downloaded in the user's terminal (computer / smartphone / tablet) when accessing certain web pages and which are stored in its own memory. Cookies allow, among other things, store and retrieve information about a terminal or user browsing habits, see pages visited, connection duration, analyze page performance, if there are technical problems and so on. Depending on the information they contain and the use of the terminal, cookies can be used to recognize the user.

What types of cookies exist?

There are various cookie types depending on different criteria:

- Depending on the ownership:
 - o Own cookies. Owned by RECOL ATLAS ATS, S.L.
 - o Third-party cookies. The cookie ownership belongs to a third-party different from RECOL ATLAS ATS, S.L., who shall treat the collected information.
- Depending on the purpose:

- Technical and/or performance cookies. Used to improve the service, solve incidences, recognize the user and so on.
- Advertising and analytical cookies. Used to analyze browsing information and offer advertisement, whether generic or personalized.

Is information collected only via cookies?

Cookies are not the only tool used to collect use, performance, technical, browsing and user's preferences data. There are also web beacons (also known as action tags or one pixel gif) pixel tags, embedded links, as well as other collection data tools (all named in a general way cookies, as it is the most usual tool). These tools generally do not identify the user, but collect browsing, preferences, page use and advertising display information.

What's a cookie used for?

Cookies are used to offer you services and/or personalized advertisement, to analyze the system performance, user recognition, find incidences and problems that may arise and solve them in the shortest term possible, as well as to analyze and measure the web page activity and use.

Is my consent needed to place a cookie?

For the installation of technical or strictly necessary cookies for the information society service rendering, expressly requested by the user, consent is not necessary.

Consent is necessary for the rest of cookies. This consent can be obtained in different ways. In RECOL ATLAS ATS, S.L. case, we shall understand consent is granted if the user keeps using the web page, regardless of the fact that at any moment such consent can be revoked and cookies deactivated.

Can I deactivate cookies?

Most browsers show how to set your browser to decline cookies, notify any new cookie, as well as to completely deactivate them. To control the use of your information, you can set your terminal browser in the most convenient way for you.

Nevertheless, should you deactivate the technical and/or performance cookies, note that the page web quality may decrease or your identification may be more difficult.
